



NEW KENNEL APPLICATION INFORMATION AND INSTRUCTIONS

Application Checklist

- Include the correct license fee in the form of a check or money order **payable to:** PA Department of Agriculture (no cash accepted). The license fee is the exact amount shown on the application.
- A Change Application must be submitted during the license year if your kennel class (size) has changed or you have moved.
 - The Change Application is due within 7 days of the change to your kennel to remain compliant. *You are responsible for paying the full price of a new license not the difference.*
 - A kennel inspection must take place in conjunction with the Change Application.
- Please be sure to indicate the mailing address for the kennel if different than the physical address.
- **COMPLETE ALL INFORMATION – incomplete applications will be returned.**
- Application **MUST** be signed by the appropriate parties as per your kennel organizational structure.

Section 206. Kennels

- (a) Applications, kennel license classifications and fees.--Any person who keeps or operates a kennel shall, on or before January 1 of each year, apply to the department for a kennel license. Kennels shall be classified by type, and the fee for the license shall be determined by the kennel type, the number of dogs housed, kept, harbored, boarded, sheltered, sold, given away or transferred in or by the kennel. The application forms and kennel licenses shall be as designated by the secretary. A separate license shall be required for each type of kennel and every location at which a kennel is kept or operated. A kennel license is required to keep or operate any kennel. All kennel licenses shall expire on December 31. When two or more licensed kennels are operated by the same person at the same location, each kennel shall be inspected and licensed as required by law.
- (1) Any person who keeps or operates a kennel shall, on or before January 1 of each year, apply to the department for the appropriate type and class of kennel license. Kennel shall be classified by type, and the fee for the license shall be determined by the kennel type, the number of dogs housed, kept, harbored, boarded, sheltered, sold, given away or transferred in or by the kennel during the previous year.
- (2) A person who did not keep or operate a kennel during the previous year shall apply for the type and class of kennel the person expects to operate during the calendar year.

(3) A person operating a kennel who changes the type or classification of kennel due to an increase in the number of dogs housed, kept, harbored, boarded, sheltered, sold, given away or transferred in or by the kennel during any calendar year shall, within seven days of the increase, apply to the department for the appropriate type and class of kennel license.

(4) The application forms and kennel licenses shall be as designated by the secretary. A separate license shall be required for each type of kennel and every location at which a kennel is kept or operated. A kennel license is required to keep or operate a kennel. All kennel licenses shall expire on December 31. When two or more licensed kennels are operated by the same person at the same location, each kennel shall be inspected and licensed as required by law. The total number of dogs housed, kept, harbored, boarded, sheltered, sold, given away or transferred in or by all of the kennels operated by that person at that location shall be counted to determine whether those kennels meet the definition of "commercial kennel" in section 102, in which case each kennel must apply for, and be inspected and licensed as, the appropriate Kennel Class C type.

Section 207. Requirements for Kennels

(a.1) Prohibition to operate; injunction; fines.--

(5) A kennel operator that is applying for a different type or class of license because of an increase in the total number of dogs or due to birth of additional dogs housed, kept, harbored, boarded, sheltered, sold, given away or transferred in or by the kennel during a calendar year shall not be in violation, provided the application is filed within seven days of the increase.

RENEWAL / CHANGE APPLICATION DEFINITIONS:

A. General Rules of Licensure: Any person who keeps or operates a kennel shall, on or before January 1 of each year, apply to the department for a kennel license. Kennels shall be classified by type and the fee for the license shall be determined by kennel type, the number of dogs housed, kept, harbored, boarded, sheltered, sold, given away or transferred in or by the kennel. A separate license shall be required for each type of kennel and every location at which a kennel is kept or operated. When two or more licensed kennels are operated by the same person at the same location, each kennel shall be inspected and licensed. All kennel licenses expire on December 31 of each calendar year.

B. Kennel Types (Definitions):

Kennel – Any establishment in or through which at least 26 dogs are kept or transferred in a calendar year, or a boarding kennel as defined in this act.

Private Kennel – A kennel not meeting the definition of "commercial kennel" where dogs are kept or bred by their owner, for the purpose of hunting, tracking and exhibiting in dog shows, performance events or field and obedience trials.

Pet Shop Kennel – Any kennel or person that acquires and sells dogs for the purpose of resale, whether as owner, agent or consignee, and sells or offers to sell such dogs on a retail basis.

Dealer Kennel – A kennel operating within the Commonwealth which:

(1) Publicly or privately sells or offers for sale any dog as an owner, agent or assignee for a fee, commission or percentage of the sale price; (2) transfers dogs at wholesale for resale to another; or (3) offers or maintains dogs at wholesale for resale to another. The term does not include a pound, shelter or common carrier or a kennel defined elsewhere in this section.

Rescue Network Kennel – A kennel that utilizes rescue network kennel homes with the goal of ultimately transferring the dog to a permanent owner or keeper through any means of transfer.

Research Kennel – Any Federal research kennel or other research kennel duly registered with and inspected by the Federal Government under the provisions of the Animal Welfare Act (Public Law 89-544, 7U.S.C. § 2131 et seq.) and its attendant regulations.

Boarding Kennel – Any establishment available to the general public where a dog or dogs are housed for compensation by the day, week or a specified or unspecified time. The term shall not include a kennel where the practice of veterinary medicine is performed if the kennel is covered by the provisions of the act of December 27, 1974 (P.L. 995, No. 326), known as the "Veterinary Medicine Practice Act." The term shall include any establishment available to the general public that, for consideration, takes control of dog(s) from the owner for a portion of a day for the purposes of exercise, day care or entertainment of the dog. For the purpose of this term, each time a dog enters the kennel it shall be counted as one dog. This term does not include any establishment engaged in only dog grooming or dog training. The term shall include any boarding facility physically detached from the veterinary practice which is operated by a licensed doctor of veterinary medicine, whether or not this facility is on the same premises as a building or structure subject to the provisions of the "Veterinary Medicine Practice Act."

Humane society or association for the prevention of cruelty to animals – A nonprofit society or association duly incorporated pursuant to 15 Pa C.S. Ch. 53 Subch. A (relating to incorporation generally) for the purpose of the prevention of cruelty to animals, which has a licensed physical kennel facility that can house a minimum of ten dogs, and which is not located on a residential property.

Commercial Kennel – A kennel that breeds or whelps dogs and: (1) sells or transfers any dog to a dealer or pet shop-kennel, or (2) sells or transfers more than 60 dogs per calendar year.

Dealer – A person who: (1) publicly or privately sells or offers for sale any dog belonging to another person for consideration, a fee or a commission or percentage of the sale price, (2) transfers dogs at wholesale for resale to another, or (3) offers or maintains dogs at wholesale for resale to another.

Out-of-State Dealer – A person who does not reside in the Commonwealth of Pennsylvania and who: (1) Sells or offers for sale a dog in this Commonwealth belonging to another person, for any type of consideration, fee, commission or percentage of the sales price; or (2) transfers a dog in this Commonwealth for resale to another or any type of consideration, fee, commission or percentage of the sales price.

C. Kennel License Categories:

1. Kennel Class – Kennels meeting the definition of any of the following "Types" fall under this category of kennels:

Kennel, Private Kennel, Pet-Shop Kennel, Dealer Kennel, Rescue Network Kennel and Research kennel.

The classification (I-VI) under this type of kennel is determined by dog numbers.

2. Boarding Kennel Class – A kennel "Type" meeting the definition of a Boarding Kennel.

The classification (I-III) under this type of kennel is determined by dog numbers.

3. Humane society or association for the prevention of cruelty to animals Class – A kennel "Type" meeting the definition of a Humane society or association for the prevention of cruelty to animals.

4. Municipal Holding Pen – A kennel "Type" run by local or state government for the housing of stray animals.

5. Commercial Kennel Class – A kennel "Type" meeting the definition of a Commercial Kennel.

The classification (I-VI) under this type of kennel is determined by dog numbers.

6. Dealer – Kennel "Types" meeting the definition of a Dealer.

The classification (I-VI) under this type of kennel is determined by dog numbers

D. Type and Class of Kennel License: The applicant shall check the box on the application next to the Type and Class of kennel he or she seeks to operate in the calendar year. *Please note that failure to properly designate the type or class of kennel could be a reason for refusal of your kennel license application. If you have any questions regarding the type or class of kennel, please contact the Bureau of Dog Law Enforcement.*

Kennel Type - The Type of kennel license shall be based on the definition under which the applicant's kennel falls.

Kennel Class - The kennel Class shall be based on the cumulative number of dogs housed, kept, harbored, boarded or sheltered in the kennel during the previous year, PLUS, the number of dogs sold, given away or transferred by the kennel.

New Kennels - For a new kennel, with no previous history, the kennel Class shall be based on the number of dogs to be housed, kept, harbored, boarded or sheltered in the kennel, PLUS, an estimate of the number of dogs that will be sold, given away or transferred by the kennel.

Change of Type or Class during the Kennel Licensure Year - If the kennel "Type" or "Class" changes during the licensure year, the kennel owner shall notify the Department of the change and file a new kennel license application within 7 days of the change. *You are responsible for paying the full price of a new license not the difference.*

- c. **Isolation Plan:** You must submit with this license application a written isolation plan for imported dogs for a period of 14 days. All kennels shall have and implement a plan for the isolation of dogs imported from another state or country to minimize the possibility of transmission of disease. The plan shall be approved by a licensed Doctor of Veterinary Medicine and must include protocols for diagnosis, testing, treatment, prevention and disinfection for contagious, infectious, communicable and zoonotic diseases. The plan shall be made available for review by dog wardens and employees of the department.

I. New Kennel Applicants:

- You must submit with this license application an Exercise Plan and Isolation Plan both approved by a veterinarian.

13. Commercial Kennels (CK Class Kennels Only):

- a. **Written Program of Veterinary Care:** The kennel in which the primary enclosure is located shall establish a written program of veterinary care, which shall include a physical examination and vaccination schedule, a protocol for disease control and prevention, pest and parasite control, nutrition and euthanasia. A copy of the program shall be kept in the kennel records.
- b. **Isolation Plan:** You must submit with this license application a written isolation plan for imported dogs for a period of 14 days. All kennels shall have and implement a plan for the isolation of dogs imported from another state or country to minimize the possibility of transmission of disease. The plan shall be approved by a licensed Doctor of Veterinary Medicine and must include protocols for diagnosis, testing, treatment, prevention and disinfection for contagious, infectious, communicable and zoonotic diseases. The plan shall be made available for review by dog wardens and employees of the department.

- 7) Kennel veterinarian on call to advise if infectious disease outbreak occurs.
- 8) If zoonotic disease possible or diagnosed, discuss appropriate PPE and any and all other steps needed to protect staff from human exposure (i.e. no immunocompromised individuals caring for these puppies).

Example: 6 months of age and over:

- 1) Immediate physical isolation of imported dogs from general population for 2 weeks.
- 2) Vaccinations:
 - Rabies vaccination 48 hours prior to transfer.

- Initial DAPP (distemper and parvo) given at least 2 weeks prior to transfer to allow for reasonable amount of efficacy.
 - Bordetella/kennel cough vaccine at least 48 hours prior to transfer.
- 3) Negative fecal test ova and parasites +/- parvo test (if under-vaccinated or no known vaccine history), +/- giardia testing.
 - 4) Dedicated staff to care for imported adult dogs who do not care for general population. If not possible, imported dogs are cared for last. PPE utilized when caring for this population. If same caretaker is used for all imported dogs, imported puppies are cared for last.
 - 5) Negative 4DX test (Heartworm, Lyme, Ehrlichia and Anaplasmosis).
 - 6) Rescue disinfectant spray and/or wipes are used to disinfect all surfaces after organic debris is manually cleaned away daily. This is subject to change if veterinary guidance suggests different disinfectant would be more effective at preventing and controlling spread of disease.
 - 7) Imported adult dogs are walked in a designated area they do not share with the general population for 2 weeks or longer if positive fecal/giardia
 - 8) Kennel veterinarian on call to advise if infectious disease outbreak occurs.
 - 9) If zoonotic disease possible or diagnosed discuss appropriate PPE and any and all other steps needed to protect staff from human exposure. (i.e. no immunocompromised individuals caring for these dogs)
